**FAQ's**

**Q: Is there a family maximum cost for families with more than 1 Girl Scout?**

A: Yes, if your family has more than 1 registered Girl Scout, the family maximum will be \$30.00. The escort will need to pay even if you have more than 2 Girl Scouts. There will be no additional cost for each Girl Scout over 2 from the same family. Example: Sandra has 3 Girl Scouts, 1 a daisy and 2 are brownies. Their father will escort them. They will pay \$30 total, \$10.00 for their father and \$10.00 for 2 of the girl Scouts. The 3<sup>rd</sup> girl will incur no additional charge.

**Q: My husband would like to escort both our daughters to the ball, but only wants to attend one session. Is it possible to arrange to have both of our Girl Scouts assigned to the same session?**

A: Yes! Please register both of your girls with one of the troops as sisters. They will both be assigned to the time for that troop. Please don't register them individually with their own troop unless you want the possibility for 2 session assignments. Both troops will be required to provide an adult helper the day of the dance. Please note the troop number of the Girl Scout who will be joining a sibling's troop, and note the name and contact information for the adult volunteer from that troop.

**Q: Do I really have to have a Troop Checking Account to pay for registration and photos?**

A: Yes, this is a requirement of the Pleasant Hill Girl Scouts. If you have any questions about this requirement, please contact Barbara Jean Guiot or Meredith Davis, who both serve on the ACT for the Pleasant Hill Girl Scout Service Unit.

**Q: Is it okay for my younger daughter to attend?**

A: No, the space just won't allow for tags for this event. We are very sorry!

**Q: Do we send the corsage order in with our registration form?**

A: No...Mail the completed Corsage Order Form with Separate Check to Tammy Jacobson/Senior Troop 1662 per instructions on enclosed order form. Please note that the dates for purchasing corsages will be different from the registration, and that Troop 1662 is managing this portion as a fund raiser for their troop.
